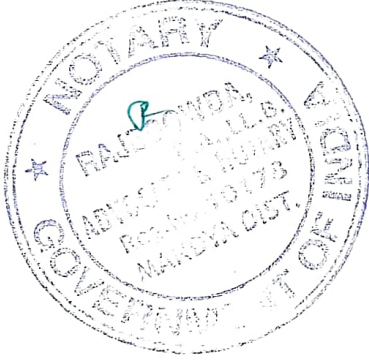
2. To improve the quality of life of the community through building awareness increasing their capacities to earn by improving existing practices/upgrading skills and creating employment opportunities.

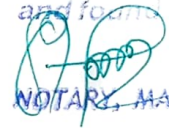

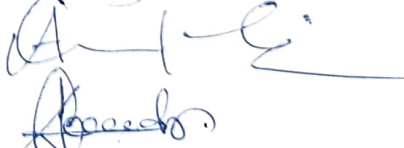

**5. MEETING OF THE BOARD OF TRUSTEES :-**

- a. The Board of Trustees shall meet not less than one in a quarter as directed by the Chairman.
- b. The Chairman may whenever he deems fit, within fifteen days on receipt of a requisition on writing from not less than THREE Members of the Board shall direct the Secretary to call the meeting thereof.
- c. In the absence of the Chairman at any meeting, the Trustees present may elect One among themselves as Chairman of the meeting.

**6. FUNCTIONS OF TRUST & POWERS, FUNCTIONS AND DUTIES OF THE BOARD OF TRUSTEES :-**

- a. The Board of trustees shall meet as open as necessary and their proceedings shall be recorded regularly in the minutes Book to be maintained for the purpose. In any resolution to be passed respecting the administration of the Trust, the opinion of the majority shall prevail. It shall be competent however for the Trustees to decide matters by circulation. In case there being a equality of voters. The Chairman of the meeting has casting vote for the purpose of deciding the issue.
- b. The Board may by resolution extend the activities of the Trust or undertake any activity in furtherance of the main objects of the Trust.
- c. Proper and Regular books of accounts of all Receipts and Expenditure of the Trust shall be maintained by the Trustees either in English or in Kannada.

**OFFICE HOURS :-** The Office shall be kept open between 10.00 A.M to 5.00 P.M on all working Days.

- ii) "YEAR" means the financial year of the Trust. The financial year of the Trust shall be First April to 31<sup>st</sup> of March of every year.
- iii) On 31<sup>st</sup> March of every year, a general accounts shall be taken up of all Assets and Liabilities of the Trust and an Income and Expenditure Account Shall be prepared and shall be passed by the trustees. Any approved Auditor shall audit the accounts of the Trust or Chartered Accountant appointed by the Board of Trustees for the purpose.
- iv) To do such other Lawful activities as are incidental in carrying out the administration and management of the Trust.

v) **THE CHAIRMAN** shall be the head of the Board of Trustees generally. He/She shall preside over all the meetings. He/She shall have power to exercise casting vote under special circumstances. The Chairman shall call the entire meeting and transact the affairs of the trust.

vi) **SECRETARY** : He /She shall be entrusted to do all the acts of administration keep proper all records and books of accounts and dealing with financial accounts of the trust, as per the resolution of the Board of Trustees, Generally, he/she shall act under instructions of the Board of the Trust and is operating Bank Account.

**BANK ACCOUNT** : The Trust shall open the bank accounts in the name and style of the Trust and the Chairman and Secretary shall operate it jointly. (The Trust can open bank account in any nationalise/Co-Operative bank )

vii) **BOARD OF TRUSTEES** : The Board of Trustees generally assists and co-operate with the managing trustees and shall be just and faithful to each other.

viii) The trustees may accept any Donation, contribution or Foreign Contribution in cash or in kind from any person, Firm, Company Corporation, Associations, Institutions or Trusts (including the settler or the trustees or any of them) for the furtherance of the objects of the trust or for any one or one of them upon such terms and conditions as they may in their absolute discretion think fit and which are not inconsistent with the objects of the trust. The trustees may take over the management of any other charitable or public institutions.

ix) Without affecting the generality of powers and functions of the trustees to manage and administer the trust, The Board of Trustees shall have the following functions.

a. To borrow if need be against the security of assets of the Trusts; by way of Bank Overdraft, Loan or otherwise as may be necessary, for the benefit of the Trust and for more effectively carrying out the objects of the Trust provided however the trustees unanimously agrees on such borrowings and limited to the terms of their decision or agreement and to authorize five or more of the trustees to execute such documents, deeds, paper etc., as may be necessary in connection there with.

b. To agree for and/or authorize the signing or executing of an agreement, contract, instrument, document or any other paper or writing required be signing or executing on behalf of the Trustees.

  9. The Trustees shall keep an account or accounts with any Bank or Banks to operate such account or accounts whether in Debit or in Credit and to give all appropriate instructions to the banker or bankers concerning the operation of such account or accounts and to authorize by appropriate resolution two of the Trustees jointly with an agent appointed by the Board of Trustees in this behalf to operate such account or accounts.
  10. The Trustees may pay all charges and out goings payable in respect of any immovable property for the time being forming part of the Trust Fund and may carry out repairs requires to be done to the same and keep the same insured against loss or damage by fire and may incur all others costs, charges and expenses incidental to the administration and management.

The Trustees shall have power to compromise or compound all actions, suits and other proceedings and settle differences and disputes touching the Trust Estate and / the Trust properties and to refer any such differences or disputes to arbitration and to adjust and settle all accounts relating to the Trust Estate and / or the Trust properties and to do all other acts fully and effectually without being liable to otherwise answerable for any bonfide loss occasioned thereby.
13. The Trustees may join, Co-operate and Amalgamate the trust creates by these presents or any portion thereof with any trust or institution having allied and or similar objects upon such terms, as they may in their absolute discretion think fit.
14. The Trustees may from time to time, frame schemes and rules and regulations to carry out the objects of the Trust and for managing the affairs of the Trust and otherwise for giving effect to the objects and purpose of the Trust and to vary the same from time to time as the Trustees may in their discretion deem fit and proper.
15. The receipts granted by the Trustees or any one or more of them for any Money, Stock, Funds, Shares, Securities or Investments paid, Delivered or Transferred to then in exercise of the Trustees powers thereof shall effectually release and discharges the person or persons paying, delivering or transferring the same there from and from seeing or from being bound to see the application thereof or being answerable for the loss or misapplication thereof.
16. The Trustees shall be entitles to at there discretion from time to time to Start, discontinue, abolish and re-start and institution, to impose any condition or conditions to any subscription or donation made by them and to earmark and portion of the Trust property or Income for any particular object or object.
17. The Trustees may reimburse themselves and pay and discharge out of the Trust Fund all expenses incurred by them in or about the execution of the trust or any of their duties under these presents including traveling and other genuine expenses, but will not be entitled to any remuneration.
18. All the Trustees unless they voluntarily resign or otherwise decide, shall continue to be the Trustees during the terms of their natural lives.
19. Any Trustees may retire at any time without assigning any reason and without being responsible for any costs occasioned by such retirement.
20. The surviving or continuing trustees may not withstanding any vacancy in their board act as trustees PROVIDED HOWEVER that if the numbers of trustees shall

not, except for the purpose of filling any vacancy, act so long as the number is below the said minimum.

21. THREE Trustees at a meeting shall form a Quorum for any meeting of the Trustees.
22. The Trustees for the time being shall elect from amongst them One Chairman and he shall hold office for 5 years, unless he resigns or refuses to act as chairman or otherwise ceases to be Trustees.
23. All proceedings and question and matters arising at the meeting of the Trustees shall be decided by a majority of votes and in case of equality of votes the Chairman shall have a second or casting vote PROVIDED HOWEVER that not with standing anything herein stated no question of dealing with disposal of the Corpus of any of the trust properties and / or investment out of the Trust corpus shall be decided except with consent of the Chairman of Trust.
24. In Case of difference of opinion between the trustees, the majority shall prevail and if the trustees are equally divided in any matter, the Chairman shall have a casting vote.
25. A resolution in writing circulated amongst all the trustees and signed by a majority of the trustees shall be as valid and effectual as if it has been passed at a meeting of the trustees duly called and convened.
26. Notice of the meeting of the Trustees and all communication may be sent to the trustees at their addresses registered for the time being in the records of the trust.
27. All meeting of the Trust shall be held at such place and at such time as the Chairman of the trust shall decide from time to time.
28. A Trustee who is unable to be present at a meeting of the Trustees may send his views on the agenda in writing and such expression of opinion shall be taken to be his vote on the matter concerned.
29. The minutes, of the proceeding of every meeting of the trustees shall be entered in a book to be kept for that purpose and signed by the chairman of such meeting or of the following meeting when they are read over and shall when so entered and signed be conclusive evidence of the business and other matters transacted at such meeting.

 Shall be eligible to be Trustee;
31. The power to appoint new or additional trustees, but so as not to exceed the maximum number and to fill vacancies in the office of the trustees, shall vest in the continuing trustee or trustees.
32. A person shall cease to be a Trustee in any of the following events:
- If he dies;
  - If he becomes Bankrupt; or
  - If he becomes insane or otherwise become incapable to act, or
  - If he resigns his office; or
  - If he is removed for guilty of misconduct.
33. On a new or additional trustee being appointed and on his signifying his acceptance in writing to the effect of his accepting the appointment. The trust property shall automatically vest in him along with the other trustees for the time being and he will be entitled to carry out all the duties and functions of a trustee without any other deed or writing.
34. The Board of Trustees shall be entitled to sue in the name of the trust and may similarly be sued in the name of the trust.
35. The Board of Trustees may by a unanimous vote of all the trustees for the time being except the trustee proposed to be removed, remove any trustee, permanent or otherwise from office after finding the trustee proposed to be removed guilty of serious misconduct in relation to or concerning the trust estate or trust affairs arriving at a definite conclusion that for the reasons to be recorded in writing to continue of the trustee proposed to be removed as trustees or these presents was desirable. Keeping to the objects of the trusts in view and other related or connected matters provided however that no conclusion of such guilt should be arrived at without giving to the trustee proposed to be removed a full and fair opportunity of explaining facts and/or the charges levied against him for his removal. And the decision of the Board of Trustees in this behalf shall be final and binding and shall not be called in question anywhere.

### 36. CUSTODY OF DOCUMENTS:

The Managing trustee / Secretary shall have the Custody of all documents, Deeds of Title relating to the trust properties and investments and the books of accounts and other records relating to the trust and shall be responsible for the preservation and production for free access of all the records and books, at all reasonable time.

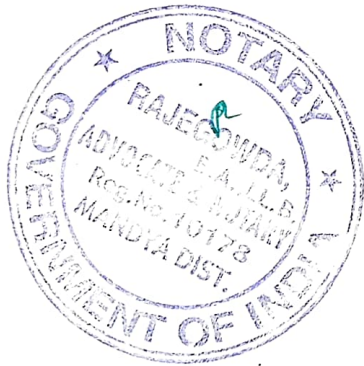

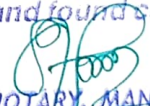
